POLI-FLEX® PEARL GLITTER is a heat sealable Flex vinyl coated with Glitter particles. The Glitter vinyls are intensely coated with sparkling, optically attractive Glitter powder due to a unique production process with solvent-free adhesive and has a good washing resistance.

Repeated repositioning of the plotted motive can be achieved due to the PET Application Tape vinyl with highly transparent acrylic adhesive.

POLI-FLEX® PEARL GLITTER is suitable to transfer onto textiles like cotton, mixtures of polyester/cotton and polyester/acrylic.

POLI-FLEX® PEARL GLITTER can be used for lettering on T-shirts, sport & leisure wear, sport bags and promotional articles.

POLI-FLEX® PEARL GLITTER can be cut with all current plotters. We recommend using a **Flock knife (60°)**. After weeding the cut flex vinyl is transferred by heat press. The PET liner should be removed warm.

Nylon and textiles with hydrophobic impregnation are not suitable for heat transfer. In this case we recommend using POLI-FLEX® NYLON.

POLI-FLEX® PEARL GLITTER is covered with a self-adhesive PET liner, enabling a reposition.

Guarantee for a secure and long-lasting bond of POLI-FLEX® GLITTER is only given when following the specified temperature and pressure conditions.

We recommend evaluation on test material.

Due to the various influences which occur from production and transfer of plotter letterings, consistency of the carrier materials and also washing and cleaning conditions, product liability can only cover the unprocessed material.
